#### **ENGLISH**

This Privacy Policy describes how your personal information is collected, used, and shared when you visit <a href="https://www.lya-electronic.com">www.lya-electronic.com</a> (the "Site").

#### 1. OVERVIEW

LYA ELECTRONIC CORP ("we," "us," or "our") takes the privacy of your information seriously and will only use the personally identifiable information ("personal information") that you provide in accordance with the terms outlined below.

This Privacy Policy covers any Personal Information we obtain when you visit our website, use our services, or access the features on any websites that we own or control (today or in the future), including <a href="www.lya-electronic.com">www.lya-electronic.com</a> (collectively, the "Site"). We will not use or share your information with any person or entity, except as described in this Privacy Policy. You can access the Site in many ways, including from a computer or mobile phone, and this Privacy Policy will apply regardless of the means of access. This Privacy Policy also governs the use of Personal Information we obtain from you from any third-party site or application where we post content or invite your feedback or participation, including, but not limited to, Twitter, Facebook, and Instagram. We cannot control the privacy policies or practices of websites or of companies that we do not own or control and cannot control the actions of people we do not employ or manage.

Please read the following privacy policy to better understand what information our website collects and uses about you and how it handles this information.

#### 2. PERSONAL INFORMATION WE COLLECT

When you visit the Site, we automatically collect certain information about your device, including information about your web browser, IP address, time zone, and some of the cookies that are installed on your device. Additionally, as you browse the Site, we collect information about the individual web pages or products that you view, what websites or

search terms referred you to the Site, and information about how you interact with the Site. We refer to this automatically-collected information as "Device Information."

We collect Device Information using the following technologies:

- "Log files" track actions occurring on the Site, and collect data including your IP address, browser type, Internet service provider, referring/exit pages, and date/time stamps.
- "Web beacons," "tags," and "pixels" are electronic files used to record information about how you browse the Site.

Additionally we will collect the information required to perform any transaction requested by you, including registering for a Site account, subscribing to a mailing list or our newsletter, participating in promotions, purchasing products offered on the Site, responding to questions or comments you may have and for any other purposes with your consent. This information may include information such as, among other items, your name, shipping address, billing information, email address, telephone number, credit card information or other payment information. When you make a purchase or otherwise utilize the Site, we may need to provide your information, including the information indicated above, to certain third-party service providers. Such third-party service providers include Shopify.com ("Shopify"), product manufacturers, shipping companies, parties used in the sending of postal mail or emails, accounting and record keeping functions, advertisements and other web-based services. Your information is disclosed to such third-party service providers only as necessary and solely to complete the transaction for which they have been engaged by us. Such third-party service providers will have access to your information for the limited purpose of completing their intended function, but they may not use it in connection with or for any other purpose. We refer to this information as "Order Information."

When we talk about "Personal Information" in this Privacy Policy, we are talking both about Device Information and Order Information.

#### 3. HOW DO WE USE YOUR PERSONAL INFORMATION?

We use the Order Information that we collect generally to fulfill any orders placed through the Site (including processing your payment information, arranging for shipping, and providing you with invoices and/or order confirmations).

Additionally, we use this Order Information to:

- to communicate with you;
- to personalize user experience;
- in the aggregate to understand how users as a group use the services and resources provided on our Site;
- to improve our Site;
- screen for potential risk and fraud;
- to improve customer service;
- to more effectively respond to your customer service requests and support needs;
- to administer a contest, promotion, survey or other Site feature;
- for direct marketing and e-marketing purposes including the sharing of Personal Information with our affiliates or third parties unless you specifically request that it not be used for that purpose.

And When in line with the preferences you have shared with us, provide you with information or advertising relating to our products or services.

We use the Device Information that we collect to help us screen for potential risk and fraud (in particular, your IP address), and more generally to improve and optimize our Site (for example, by generating analytics about how our customers browse and interact with the Site, and to assess the success of our marketing and advertising campaigns).

#### 4. SHARING YOUR PERSONAL INFORMATION

We share your Personal Information with third parties to help us use your Personal Information, as described above. We also may disclose your Personal Information:

- if, in our reasonable judgment, it is necessary to enforce compliance with our internal policies or to protect our Site, customers, or others;
- to any other entity that acquires all or a portion of our organization by merger, reorganization, operation of law, or a sale of some or all of our assets;
- in response to lawful requests by public authorities, and to meet national security or law enforcement requirements; and
- to comply with applicable laws and regulations, to respond to a subpoena, search warrant or other lawful request for information we receive, or to otherwise protect our rights.

#### 5. BEHAVIOURAL ADVERTISING

As described above, we use your Personal Information to provide you with targeted advertisements or marketing communications we believe may be of interest to you. No method of transmission over the Internet, or method of electronic storage, is completely secure. Therefore, we cannot guarantee the absolute security of your Personal Information. When you place an order through the Site, we will maintain your Order Information for our records unless and until you ask us to delete this information.
